

Opportunity for members of the public to raise issues with the Council (2 mins maximum PP) on any items relating to the agenda. Also, a chance to receive a report from the District & County Councillors. Once the meeting has been opened, no further comment may be taken without the agreement of the Chairman.

- 1. Apologies & Absence-** To receive apologies and note absence.
- 2. Declarations of interest & consider request for dispensations** to receive declarations from Councillors, any DPI 's (disclosable pecuniary interest or simply an interest termed a personal interest in the Code the Council adopted) relating to any items on the agenda for April 16th 2024. (Councillors should also remember that even if they do not stand to gain in any personal way, also to be considered is the public's perception of whether a councillor might gain by being influenced or using influence in a personal capacity.)
- 3. Minutes of the last meeting-** To confirm and sign the minutes of the Full Council meeting held on March 19th 2024 (distributed by email & hand).
- 4. Committee Meetings- To note** there was no Planning & Finance meeting held on 2nd April. To agree staff & associate cost for April 2024 as stated on payment schedule 23.04.24.
- 5. Elections 2nd May 2024** -To note that we have received a 'Notice of Uncontested Election' and therefore there will not be an election on 2nd May for Hinton Parish Council. All Councillors will take office on Tuesday 7th May. Each Councillor should sign the Declaration of Acceptance of Office and be attested by the Clerk as the proper officer of the Council before or at the first meeting. All Councillors must complete a Disclosure of Pecuniary Interest form.

- 7. Councillors Report** - A brief report from Cllrs to **bring members up to date** on **Parish matters** since the last meeting. **No** decisions can be made under this heading but can be an agenda item for the next meeting.
