- 2. Apologies & Absence None Received
- 3. **Declaration of interests on agenda items** Cllr Beard declared an interest in item 5. 18 Oldminster Rd. Clerk mentioned that she has noticed that the closing date has passed so no comment can be made on this application.

  S.22/0148/HHOLD- 10 Oakfield Way- Demolition of singe storey & side extension and erection of two-story side and single storey rear extension. Installation of dropped kerb and hardstanding. Permitted
  S.22/0416/P3R- Luggs farm Station Rd Sharpness- Change of use from Agricultural to flexible use. Prior approval granted subject to conditions
  S.21/3063/FUL -Land of Severn Road Sharpness Berkeley- Erection of a steel frame storage unit. Permitted.
