Also, a chance to receive a report from the District & County Councilors. Once the meeting has been opened, no further comment may be taken without the agreement of the Chairman.

- 1. Apologies & Absence-** To receive apologies and note absence.
- 2. Declarations of interest & consider request for dispensations** to receive declarations from Councillors, any DPI 's (disclosable pecuniary interest or simply an interest termed a personal interest in the Code the Council adopted) relating to any items on the agenda for June 18th 2024. (Councillors should also remember that even if they do not stand to gain in any personal way, also to be considered is the public's perception of whether a councillor might gain by being influenced or using influence in a personal capacity.)
- 3. Minutes of the last meeting-** To confirm and sign the minutes of the Full Council meeting (Annual Council) held on May 21st 2024 (distributed by email & hand).
- 4. Committee Meetings- To note** the minutes from the Planning & Finance meeting held on 4th June 2024. To agree staff & associate cost for May & June 2024 as stated on payment schedule 04.06.24.
- 5. Internal Controls-** To consider a member to carry out internal controls for the period June-September 2024.
- 6. Petition-** SDC have had approval for a budget of up to £100k, for Junction 14 of the M5 for design and costings to allow the Draft local plan examination to continue. [Stroud Council Minutes April 25th 2024](#) – This is Stroud Councils Tax payer money for an area that is in South Gloucestershire- **To consider** the possibility of starting a petition.

- 7. Garden Competition 2024- Cllr Birnie** would like to continue with the garden competition from June-September 2024. There is money left in reserves from the grant to purchase vouchers this year. **To consider the above.**
- 8. Fly Tipping – Cllr Fryer-** Cllr Fryer has noticed the increase of the fly tipping of Highway/District Signs in the Parish. Road works seem to be carried out and signs/bollards just left in the hedge- **To resolve** the action to take.
- 9. Bench at the top of Oldminster rd.- Cllr Beard-** Cllr Beard has been approached by a few parishioners regarding the condition of the bench. The parishioners are asking for a new bench. **To consider the request.**
- 10. Lease- To consider** appointing a solicitor at £350.00 plus vat to read the Vindicatrix lease before it is signed. **To resolve the above**
- 11. Re Seeding of Goal mouth and centre spot-** Cllr Brown-**To resolve** to reseed the goal mouths and centre spot before the new season starts.
